School Fees, as determined by the Board of Governors, are compulsory and if paid annually are due by February each year. Fees can be paid monthly, January to December inclusive (over 12 months).

**Please note your first payment must be made by the 14th January 2026. Thereafter fees must be paid from 1<sup>st</sup> to 5<sup>th</sup> of each month, February to December 2026.**
